# **SELECTION CRITERIA**

Rise Up is launching the third cohort of the Youth Champions Initiative, in partnership with the David and Lucile Packard Foundation. The Youth Champions Initiative (YCI) is an exciting initiative that is advancing innovation and quality in the field of sexual and reproductive health and rights globally. Through YCI, Rise Up invests in young champions who are leading the sexual and reproductive health, rights, and justice (SRHRJ) movement now and for the next generation.

Following a competitive selection process, Rise Up will select 22 visionary young people working in Packard Foundation priority geographies – India, Pakistan, Ethiopia, Rwanda, and the United States (Louisiana and Mississippi). YCI integrates intensive capacity building, leadership development, mentoring, project funding, and technical assistance to enable young leaders to launch creative new initiatives to improve SRHRJ in their countries.

The submission deadline for the Youth Champions Initiative application is March 15, 2019. Eligible candidates must meet the following selection criteria:

- 1. Young persons between the ages of 18-29
- 2. Residents of:
  - India
  - Pakistan
  - Ethiopia
  - Rwanda
  - Louisiana and Mississippi, USA
- 3. Personal dedication to improving sexual and reproductive health and rights
- 4. Commitment to social change and experience in one or more of the following areas: youth development, education, sexual and reproductive health and rights, innovation and/or related fields
- 5. Support of the applicant's organization and ability to participate in a workshop in Los Altos, California, USA in June or July, 2019.
- 6. To be eligible for a grant in association with this project, Rise Up requires organizations to hold tax exempt status, and in India to be registered under the Foreign Contribution Regulation Act (FCRA). Entities that are not registered can be sponsored by a legally registered entity.
- 7. Proficient in oral and written English
